PER CURIAM: 1 Plaintiffs Ricky Thomas Cross, Perry R. Evans, and William A. Gray appeal from so much of a judgment of the United States District Court for the Southern District of New York, David N. Edelstein, Judge, as dismissed, after a jury trial, their claims that defendants Thomas Coughlin, III, former Commissioner of the New York State Department of Correctional Services ("DOCS"), T. Janak, Grievance Coordinator of DOCS, A. Vellone, Commissary Director of DOCS, and R. King, Food Services Supervisor of DOCS, violated their rights under the Fourteenth Amendment to the Constitution, 42 U.S.C. Sec. 1983, the Eighth Amendment to the Constitution, and the collective bargaining agreement between the DOCS and the New York Correctional Officers & Police Benevolent Association ("NYCOPBA"). Although plaintiffs do not challenge any of the rulings of the district court denying their motion for a preliminary injunction and denying class certification, they contend that the jury's verdict for defendants was against the weight of the evidence and that the district court erred by denying their motions for leave to amend their complaint and for judgment notwithstanding the verdict. We disagree, and we affirm the judgment of the district court. 2 Plaintiffs alleged in their complaint that the conditions of confinement in the Special Housing Unit ("SHU") at Southport Correctional Facility

were so severe as to constitute cruel and unusual punishment. They sought compensatory damages, but did not seek, and were not entitled to, punitive damages under section 1983.
